Grantee Report	<p>C. Doria-Ortiz delivered the Grantee Report. Highlights of the report include:</p> <ul style="list-style-type: none"> ○ The AA has not yet received their Notice of Grant Award (NOA), however, it was announced during the HRSA Terms Report Webinar on May 31, 2018 that all jurisdictions had received their NOA's. We notified our Project Officer via email of our absence of an NOA and she is following up on the status of SATGA's NOA. The Part A and MAI Program Terms Webinar was attended by Ryan White staff on May 31, 2018 with guidance on preparing and submitting the two-part submissions: 1) Program Terms Report and 2) Program Submission. ○ <u>Personnel Update:</u> ○ The Ryan White Program will be utilizing the assistance of a Public Health intern from the University of Texas at San Antonio, Alondra Zapata throughout the summer and fall of 2018. She began her duties on May 31, 2018 and will play an integral part in conducting tasks that help the AA, sub-recipients, and community stakeholders in support of the continuum of care. Veronica Avalos, the Financial Grants Supervisor will be out for approximately 6 weeks beginning May 21, 2018. ○ <u>Community Activities:</u> ○ The 2018 National Latino HIV/Hep C Conference was held on May 19-21, 2018 in San Antonio and attended by the Planning Council and Ryan White Program Staff. The Ryan White Program provided a booth with informational resources throughout the event and participated in plenaries and breakout sessions that covered topics such as: The Power of Peers, Re-engaging Latinas into care; Molecular Surveillance, What does it all mean?; The HIV Treatment Cascade and Latinos; Hepatitis C and HIV, A Panel Discussion; 50 Plus HIV; Establishing A Quality Culture; Substance Abuse; Youth and HIV; The B Word: Buprenorphine and Social Workers; and Ending the Epidemic Tool Kits. The conference was very productive as it provided numerous resources on Latinos and AIDS that the AA will be utilizing in upcoming events and trainings. ○ The kick-off for the revitalization of Syringe Exchange Programs was held on May 23, 2018 with a Syringe Services Program Summit, attended by the Ryan White Director and Assistant Director. Information on the following topics were given: Benefits of Syringe Services Programs; Legal Status of Syringe Exchange in Bexar County; State Perspective on Syringe Services; and Available Resources including the Resource Guide by the San Antonio Area 	

HIV Health Services Planning Council for accessing core and support services for those infected with HIV.

- The committee called End Stigma, End HIV Alliance (ESEHA Alliance) continue to meet bi-weekly. It currently is obtaining community input by conducting facilitated trainings provided by United Way. In addition it continues to support the Fast Track Cities activities including one focusing on youth.
- Two community events were held on May 5, 2018 which the Ryan White Program supported through the provision of resource materials:
 - The 20th annual Baile de Vida hosted by Mujeres Unidas; and
 - The Young Minds Matter teen event called “A Beautiful Mind: Breaking the Stigma of Mental Health” hosted by The Health Collaborative
- **Webinars and Trainings:**
- Ryan White Staff participated in 17 trainings and meetings throughout the month of May. Trainings and topic discussions included: Effective communications training; Ryan White and BCHD integration of policies; Outreach and Ryan White/HIV activities; Management Development training; Finance and Accounting; collaborating between the AA and Planning Council; and invoicing procedures.
- May 8, 2018 – Conducting RWHAP Part A Planning Council/Planning Body Needs Assessments Webinar attended by RW Staff
- Ryan White staff attended the How to use HIV Quality measures Module Webinar on May 17, 2018. The HIVQM Module is a tool developed by HAB to help recipients monitor their HAB performance measures. This tool is an easy-to-use and structured platform that allows recipients and sub-recipients to continually monitor their performance in serving their clients, particularly in access to care and the provision of quality HIV services. The tool also allows recipients to generate reports that compare providers regionally and nationally.
- The Health Collaborative, as the local performing site for the South Central AIDS Education and Training Center (SCAETC) conducted their first HIV 101 Physician’s Training on May 25, 2018 with Ryan White Staff and sub-recipient staff in attendance. This training was provided by Dr. Delia Bullock of UT Health and the University Health System FFACTS Clinic, acting as the Clinical Director for this Local Performing Site. Approximately 30 individuals attended this very informative training.
- A fourth conference call was held on May 14, 2018 with the HRSA Care Continuum Learning Collaboration (CCLC). The SATGA and CCLC team discussed the SATGA Non-Virally Suppressed Needs Assessment; data matching; Technical Assistance needs; discovering short-term goals; and available community resource materials.
- The preparation and submission of the Part A Progress Report was conducted during the month of May with two progress and technical assistance meetings held among Ryan White staff. The report was submitted in a timely fashion on May 30, 2018.
- The HIV/Syphilis Testing Taskforce was held on May 3, 2018 with 29 attendees. A hands-on training on the Rapid HIV Test was provided by BioLytical Lab where attendees were given the opportunity to test one another and learn about the different types of instant tests available. Discussions were also held around planning the upcoming World AIDS Day (December 1, 2018).
- Due to the recent resignation of the community co-chair for the HIV/Syphilis Testing Taskforce, an orientation was held on May 10, 2018 for the newly elected co-chair, Luka Rios of Alamo Area Resource Center to educate her on the history of the Taskforce and the roles and responsibilities of the community co-chair position.
- The Ryan White AA staff continues to utilize and promote the HRSA Target Center Quality Academy modules to sub-recipients for learning how to enhance the Quality Initiatives within their respective agencies as directed by the Quality Management Committee and at the QM SPOC meetings. See the attached CQM and CQM SPOC binder Table of Contents.
- The EnrollSA Partners held an ACA 2018 Open Enrollment update meeting on May 1, 2018 where concerns and future plans were discussed on the following topics: challenges from the 2017-2018 enrollment period (ie misinformation, shorter enrollment period, new administration, and increased premiums) and anticipated challenges for the 2018-2019 enrollment period (ie reduced funding and number of enrollers/assisters, introduction of short-term plans, and increased premiums).
- A monthly reminder is sent to sub-recipients concerning THMP/ADAP due dates to assist case managers in helping clients with the new birthdate recertification schedule. The reminders detail specific timeframes to mail reminders and ensure no gaps in service as re-certification and self-attestation dates are met.

	<ul style="list-style-type: none"> ○ A special Health Advisory from the Department of Health and Human Services, Health Resources and Services Administration was issued on May 18, 2018 indicating the potential risk of antiretroviral medication dolutegravir (DTG) with associated neural tube birth defects; the Health Advisory was forwarded to all sub-recipients and community stakeholders. ○ Ryan White AA staff and Sub-Recipient ADAP Eligibility Worker (AEW) case managers attended the ADAP Regional Training Update on May 3-4, 2018 in Austin, TX. Topics that were covered included: Regional Activities; THMP Eligibility-Application Process; AEW Performance Measures for reporting; Medication Adherence/Viral Suppression; Recertification Timeline; and practical applications in understanding the application process.
